

2010 Terms of Participation Agreement

Land of Waterfalls Art Gallery Annual Art Festival in Cedar Mountain, N.C. will be held on Saturday, September 25th, 2010 from 10AM to 5PM. Participating vendors are required to begin and end sales according to the times listed above. Each vendor must provide adequate personnel and merchandise for these hours.

Booth Spaces:

Vendors will be emailed or mailed assigned booth spaces prior to the scheduled show. Should you not receive your booth reservation, please call Rose at 884-9606.

Booth Set-up Times:

All Vendors must check in at **check in site** before setting up their booth. Vendors may check in and begin setting up on Saturday morning between 7am and 9:45am. Set-up must be completed no later than 9:45am. All vendors are required to set-up his/her booth prior to the opening of the show unless a verifiable emergency occurs and the vendor notifies the Show Committee. Vendors who have not complied by the start of the show may be denied their space for the day at the discretion of the Show committee with forfeiture of booth fees.

Vehicles:

Vehicles may be brought up to their location to unload only. You must move your vehicle as soon as you unload, not after you set-up. Vendors should park their vehicles in designated areas.

Use of Allocated Space:

Only arts specifically listed by the vendor/exhibitor on his/her application may be displayed. No more than two (2) exhibitors per booth will be allowed unless specific Show Committee permission is received. In no event may a vendor/exhibitor sublet a booth or any space within it.

Vendors shall not use noise making devices or public address systems in or around their allocated space without prior approval.

Vendors shall maintain allocated space and vending unit in a neat, safe and orderly condition during the show.

Vendors shall provide their own tables.

Vendors are responsible for setup and removal of their own equipment, fixtures, inventory and other property

Children accompanying the exhibitor must be well mannered and under adult supervision at all times. In no event will children be allowed to play unattended in the show area.

Booths will be attractive in nature. Stock will be neatly piled and/or out of sight.

Closing Times:

Closing times will be strictly adhered to. **Early breakdowns of booths are prohibited.** Vendors may not remove display items or begin to take down booths before show closing time unless the Show Committee gives specific permission.

The following items are strictly prohibited:

Alcohol or any illegal substance, firewood of any kind, pets, unless specifically permitted by the Show Committee, signs announcing going out of business, etc., fish hooks, sharp objects or weapons of any type, unless specifically approved for sale, and smoking inside the building.

The vendor accepts the decision of the Show Committee in disputes between the exhibitor/vendor and any other Show participant or on any matter not covered by this agreement.
